

When the grant writer at Malta House of Care in Hartford, CT saw the criteria for the 2018 grant application to the CVS Health Foundation, she knew there was only one thing to do: turn to the Clinic's Medical Director for help! Through meetings and emails, the two women came up with a project to help address hypertension among Malta's patients – and add \$20,000 to the Clinic's bottom line. The result: Malta got the grant – and more than half of the 100 HTN patients in the project's cohort had improved BPs by the end of the grant period.

They will share how they implemented this tool, what the data yielded and how they used it to impact patients' health and secure additional funding for their clinic.

PATIENT CARE 3.1 - Location: Mercer Salon G

An Integrated Non-Opioid Pain Management Program in a Free Clinic Setting

Presenter: Mary Wirshup, MD, FAAFP, Vice President of Medical Affairs, CVIM

25 million Americans suffer from chronic pain. At the same time, the United States is facing an opioid addiction crisis. This presentation will discuss one free clinic's integrated Non-Opioid Pain Management Program. CVIM is able to use volunteers in various specialties to help decrease pain in their patients. In addition, there will be a discussion on how education, behavioral health and medications help improve their patients' quality of life. Finally, data will be presented on the use of a validated pain assessment tool called PEG. Overall, this free clinic program has helped decrease their patients' pain, improved their quality of life, and given them more hope.

One Clinic's Transformation Through High-Performance Governing

Presenters: Mark Cruise, Executive Director, Volunteers in Medicine America; Jeannie Shapiro, RN, Clearwater Free Clinic Peter Drucker, a towering figure in the field of management, said, "There is one thing all boards have in common... they do not function." Many boards are ineffective, not because they want to be, but because they never learn what governance is and/or don't know of a system with which to practice excellent governance. This is the story of how Clearwater (FL) Free Clinic's board and CEO got tired of the status quo and decided to up their game by becoming a Policy Governance organization.

University-Community Partnership to Enhance Public Health Communication

The local 'free clinic' in Lincoln Parish has teamed up with the local university to help fill some healthcare gaps that have been identified in the area. Access to healthcare is limited for the uninsured, and then when they do find it, resources are minimal, and the educational element is often skimmed over, or left out altogether. Through a project initiated by their local college, they utilized the students' talents, and helped to meet some needs of their patients. The students are able to then evaluate how effective their artwork or educational pamphlet is by direct feedback from the patient.

Telehealth: Empowering Rural Communities

Join this session to learn about a national collaboration designed to collect and report on patient outcomes and processes across free and charitable clinics. Launched in 2017 and now in its second year, the "Roadmap to Health Equity" project is a multi-stage, multi-year voluntary initiative that currently involves nearly 80 participants across the free and charitable clinic sector. Every year, over \$5 Billion in prescription drugs are wasted when long-term care residents, patients, and others no longer need them. Prescription drug repositories reclaim unused medications and provide them to patients in need. 


