#### **#FreeClinicsCare: A Campaign to Reframe Perceptions of Free Clinics**

When the need for accessible healthcare in Virginia was never more apparent as a result of the pandemic, the VAFCC launched an awareness campaign to reach out to their communities, the public, and local businesses to drive greater understanding of free clinic services, challenge common misperceptions, and encourage additional financial support. There were three goals for this campaign: make sure that families and individuals across the state who needed affordable healthcare knew about and had access to free clinics; address an immediate need for volunteers to help clinics continue to provide essential care to those who would otherwise go without; and enhance fundraising that had been hurt by the pandemic while operating costs were increasing. The result was the VAFCC's "#FreeClinicsCare" public awareness campaign.

#### **Virtual Management of Diabetes and Hypertension**

<u>Speakers</u>: Tchernavia Montgomery, MSW, LCSW, Executive Director, Care Ring; Rebecca Palmer, Care Ring

Like many primary care clinics across the country, Care Ring implemented a virtual care model in early 2021 in response to the COVID-19 pandemic. This session will provide an overview of our experience implementing virtual diabetes and hypertension management, utilizing case studies of its impact within our predominantly Spanish-speaking patient population. We will discuss lessons learned, qualitative and quantitative analysis of the impact of virtual chronic care management, as well as an evaluation of our post-COVID virtual care workflow. Specific areas of focus include best practices in use of virtual care to support at-home monitoring and self-management, opportunities to increase patient engagement, and virtual care program evaluation.

Free and Charitable Clinics CHARTing their Future Using Quality Metrics: Update on the Roadmap to Health Equity National Collaborative

Speakers: Julie Darnell, Associate Professor, Loyola University Chicago; Martin Zannin, Crossover Health Ministries; Shelby Miller, Executive Director, Hope Clinic
Join us to learn about an exciting multi-stakeholder collaboration designed to collect and report on patient outcomes across free and charitable clinics (FCCs) on a national scale. Launched in 2017 and now in its fourth year, the Roadmap to Health Equity project is a grassroots consortium of FCCs and state associations who are working to improve the quality of care and reduce health inequities for FCC patients. The centerpiece is a national data repository containing 15 evidence-based clinical quality measures, a cutting-edge patient experience measure, and patient-level characteristics, including race, ethnicity and language. Nearly 50 pilot clinics are currently testing the reporting of the clinical quality measures into the custom-built data repository. Come hear about the progress we've made, why reporting on standardized, evidence-based patient outcomes matters, how data can support improvements in equity, the early lessons learned from collecting outcomes data nationwide, and how your clinic can become involved.

**Bridging the Gap to Mental Health**

The cost of mental health services is a barrier to accessing care to individuals without insurance. However, mental health issues affect our over all physical health. In order to overcome these issues, mental health services were implemented at Heart and Soul Clinic. This session will describe the planning and implementation of this program and the current outcomes of the services. Attendees can expect to learn about the process that Heart and Soul Clinic went through to create Free Mental Health services for the uninsured patients that are served. Each stage of the process will be reviewed such as concept, planning, implementation, and revision. With each stage of process, the partners, resources and concerns will be identified so that other clinics might be able to see what their community could offer. The implementation of the brief solution focused mental health services will be showcased. With further discussion on how these services continue to be revised and improved.

We have all likely been guilty of perpetuating cancel culture. We are advocates of change, social justice and anti-discrimination, all worthy aspirations but we must be careful to guard against our ego and proclamation of a moral high ground. We are the woke, the fighters of liberation and equity. Yet, our "wokeness" can run afoul if we call people out in a manner that publicly shames and ignores the complexity and nuance of their humanity. Cancel culture has its place but in some circumstances it may lead to divisiveness rather than unity. It is time to rethink our strategy for getting people involved in our inclusion movement. What if instead of calling people out, we called them in?

## Free and Charitable Clinics as an Equity Tool to Reduce Maternal Mortality in America

<u>Speaker</u>: Michelle Drew, DNP, MPH, APRN-BC, Executive and Clinical Director, Ubuntu Black Family Wellness Collective

Black mothers are 2-3 times more likely to die from pregnancy-related complications and Black infants are 2-4 times more likely to die in the first year of life than their white counterparts. While we know that these disparities are true regardless of income and education, low-income Black mothers and babies bear the highest burden of morbidity and mortality rooted in the social and structural determinants of health. Black families are more likely to uninsured and underinsured. Black women are typically paid 68% of their white male counterparts doing the same work and are more likely to live in food and healthcare deserts. This session will discuss how free and charitable clinics can position themselves to better serve as a preventive measure in preventing perinatal health disparities in mothers and babies through developing care paradigms rooted in antiracism, reproductive justice, and birth equity and serve as primary prevention against perinatal mortality.

Innovating Health Care Access: Rethinking Space and Place for Care

<u>Speakers</u>: Stephanie Willding, MPA, CEO, CommunityHealth; Avelle Bailey, MPH, Manager of Strategy and Innovation, CommunityHealth

CommunityHealth has added a dimension to their focus on patient-centered care through the launch of telehealth microsites. As a response to COVID-19, many appointments transitioned to telehealth in 2020, but some patients faced technological barriers to video visits. At the same time, providers still needed to collect patients' vitals and labs, which was not possible via telehealth. CommunityHealth partnered with an establish community organization in a neighborhood where the largest number of patients live and work to establish its first telehealth microsite. This small clinic location is staffed by a medical assistant and has a private room with equipment for video visits. Here, patients can have labs and vitals checked, as well as complete an assisted virtual

visit with their primary care provider. This model is designed to be easily replicated and will demonstrate a new, low-cost way to expand access to care.

Social Determinants of Health: Practical and Sustainable Strategies for Free and Charitable Clinics

<u>Speaker</u>: Breanna Lathrop, DNP, MPH, FNP-BC, COO, Good Samaritan Clinic The COVID-19 pandemic and increased focus on racial inequities have highlighted persistent health disparities and the impact of social determinants of health. Free and charitable clinics in have firsthand knowledge of the social determinants affecting their communities and are actively seeking strategies to foster health equity but often lack the staff and internal capacity to address them. This session will focus on sustainable and practical strategies for clinics wants to expand their ability to address social determinants of health. This includes:

- Internal organization work such as staff education, addressing bias, monitoring for disparities and diversifying leadership
- Patient focused strategies including screening for SDOH, transportation strategies, food access, programmatic strategies, and use of new roles to address SDOH
- Community focused strategies such as community partnerships, outcome management and reporting, and resource mapping Free and charitable clinics understand the health impact of social determinants of health and have long been innovators in addressing social needs.

In the current health care environment community members are over surveyed. Which has resulted in tons of data being collected that is not always useable. At NOVA ScriptsCentral, we partnered with various organizations and conducted 3 surveys. Our engagement with the diverse demographic population helped us mold culturally competent survey questions to address the concerns of the underrepresented

population. We are excited to show how we leveraged the data we collected to improve our health communication and program implementation. Our goal is to highlight how we were able to successfully get 2,500 respondents to engage in a total of 3 surveys. We want to demonstrate how our organization was able to redesign our outreach approach by incorporating a culturally competent lens for equitable engagement. Through this learning journey, we learned the importance of using data visualization tools to help make the data relevant to various stakeholders. We will be demonstrating how organizations can use the data visualization to improve health communications and programs.

#### Advocacy 101 – Getting Back to the Basics

#### A Student-Driven, Compassionate Model to Initiate Patients on Gender-Affirming Hormone Therapy (GAHT)

<u>Speakers</u>: Omid Cohensedgh, B.A., Medical Student Q Clinic (Columbia University Vagelos College of Physicians and Surgeons); Lotanna Ezenekwe, B.A., Medical Student Q Clinic (Columbia University Vagelos College of Physicians and Surgeons)

Transgender and gender non-conforming (GNC) patients encounter a range of barriers in accessing health care, including lower rates of health insurance coverage and prior

negative experiences in healthcare settings. These patients are also often turned away from providers or required to educate their providers on their own health care. This session will introduce attendees to gender-affirming hormone therapy (GAHT) and how to integrate it into clinic practice. The presenters are two medical students who are part of Q Clinic, a student-run free clinic that aims to provide compassionate medical care to patients marginalized due to their sexual or gender identity. In the course of this session, we will cover how to create a sensitive and respectful care environment, obtain a patient history, consider GAHT regimens, and communicate treatment expectations with patients. We will also provide protocols detailing treatment timeline, treatment regimens, laboratory monitoring, expected effects and risks, and ongoing care.

#### The SDOH Tools of the Future are Here!

<u>Speaker</u>: Phyllis Albritton, Managing Consultant, Colorado Safety Net Collaborative The pandemic has taught us that while we are still in the business of helping people get and stay healthy, that is not always something that can be done in person. Health reasons and changing demographics are leading the way to better SDOH tools for clinics to provide these services while meeting patients where they are and keeping everyone safe from viruses, etc. Learn about the tools that are developing and how you can use them to connect and expand your SDOH reach for your patients as well as proving to funders how connected you are to your community.

#### Thomas Tighe, President and CEO, Direct Relief



Thomas Tighe has served as President and CEO of Direct Relief, a nonprofit humanitarian medical organization, since October 2000. Since Tighe's arrival, the organization has provided cash grants of more than \$170 million and furnished more than \$9 billion in essential medicines, equipment, and supplies to support health services for low-income people in over 100 countries and all 50 U.S. states, where the organization conducts the country's largest nonprofit charitable medicines program.

During Tighe's tenure, Direct Relief has been named among the world's most innovative nonprofits by Fast Company, has been rated by Forbes as being 99 percent efficient or better in fundraising since 2001, won the Peter F. Drucker Award for Nonprofit Innovation, the CECP Director's Award, the Esri President's Award for GIS

innovation, the Office of the Surgeon General's National Leadership and Partnership Award, and became the first U.S. nonprofit to obtain NABP Drug Distributor Accreditation to distribute Rx medications in all 50 U.S. states.

From 1995 to 2000, Tighe served as Chief of Staff and Chief Operating Officer of the Peace Corps, overseeing day-to-day operations of the agency's worldwide programs and a resurgent growth to a 27-year high. From 1993 to 1995, Tighe served as Associate General Counsel of the Peace Corps, negotiating bilateral agreements to initiate Peace Corps programs in South Africa and China. From 1989 to 1993, he served as Associate Counsel on the U.S. Senate Committee on Veterans' Affairs, conducting oversight and developing legislation related to veterans' mental-health care, special disability programs, drug and alcohol treatment, and services for homeless veterans. Tighe also handled collateral duties related to foreign aid and the Peace Corps. A 1982 graduate of the University of California, Berkeley, Tighe received a J.D. in 1985 from the University of California, Hastings College of Law, and an Honorary Doctorate of Laws from Hobart and William Smith Colleges in May 2003.
