BACKGROUND

The National Association of Free & Charitable Clinics (NAFC) is dedicated to building healthy communities for all through quality, equitable, accessible healthcare.

There are over 1,400 free and charitable clinics and charitable pharmacies in the United States. These organizations are a critical part of America's safety net. They exemplify the concept of private/public partnerships and operate through the generosity of donors, partners, and volunteers as they receive little to no Federal Funding.

Free and charitable clinics and charitable pharmacies focus on the overall needs of uninsured and underinsured people in their communities throughout the country. They provide a wide range of services to address health disparities in their communities, including (but not limited to) medical, dental, pharmaceutical, mental health, vision, and health education services. They also take on social determinants of health through programs like food pantries, job and housing assistance, transportation, and more.

Our members and the NAFC are dedicated to building healthy communities and a healthy America, one person at a time.

The data in this report is collected from the NAFC membership annual data collection and reflects 2022 data.

— 1.8 million in 2021, 1.7 million in 2020

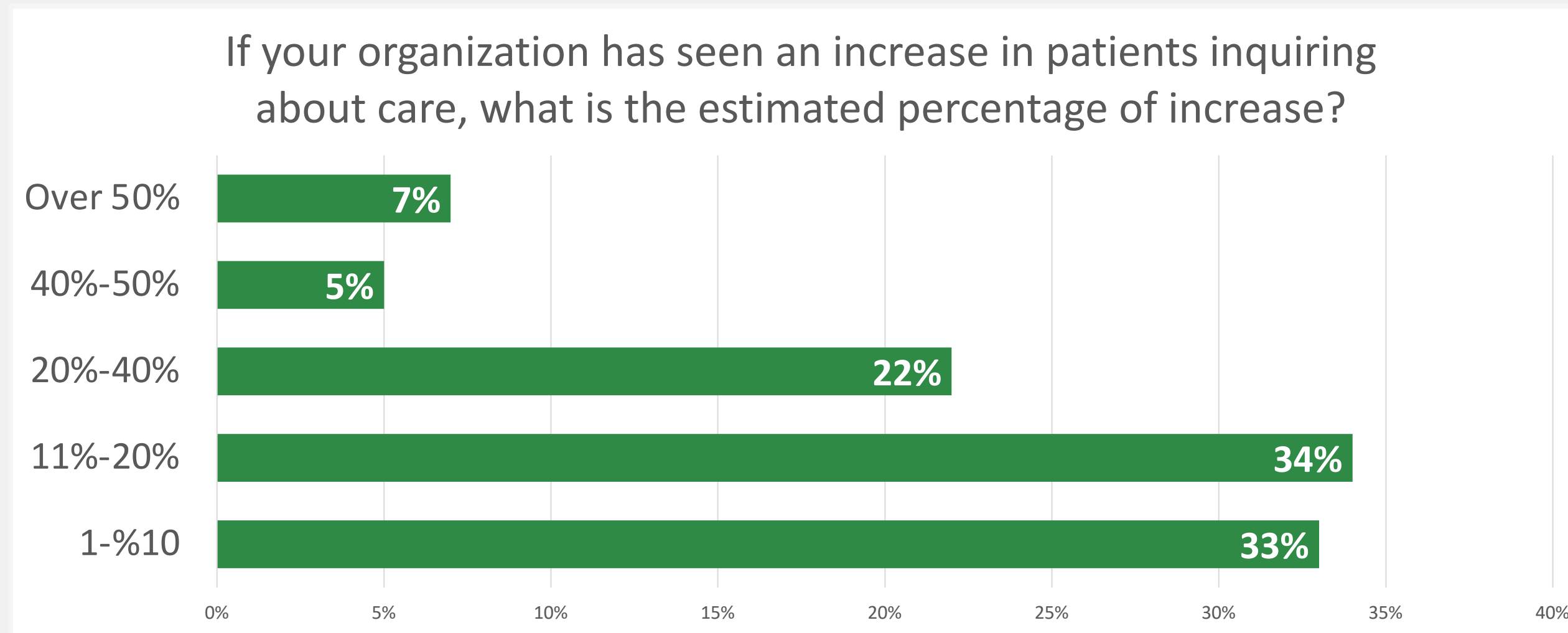
New Patients in 2022: 628,000

PATIENT DEMAND

73% of NAFC member organizations reported seeing an **increase** in patients inquiring about care in the past year, an increase from 68% in 2021.



- 64% of clinics report not being at capacity, 20% report currently being at capacity for certain services and having a waiting list, and 16% report currently being at general capacity for patients and having a waiting list.



PATIENT DEMOGRAPHICS

93% of patients seen in 2022 were uninsured

Of the number of patients that were insured, almost 50% were noted to be insured but unable to afford care (underinsured)

- *2021 - 85% of patients seen were uninsured*
 - *Of the number of patients that were insured, 70% were noted to be underinsured*

65% of patients seen in 2022 were employed

- *52% of patients seen in 2021 were employed*

Type of area patients generally reside:

- Rural – 35%
- Urban – 35%
- Suburban – 30%



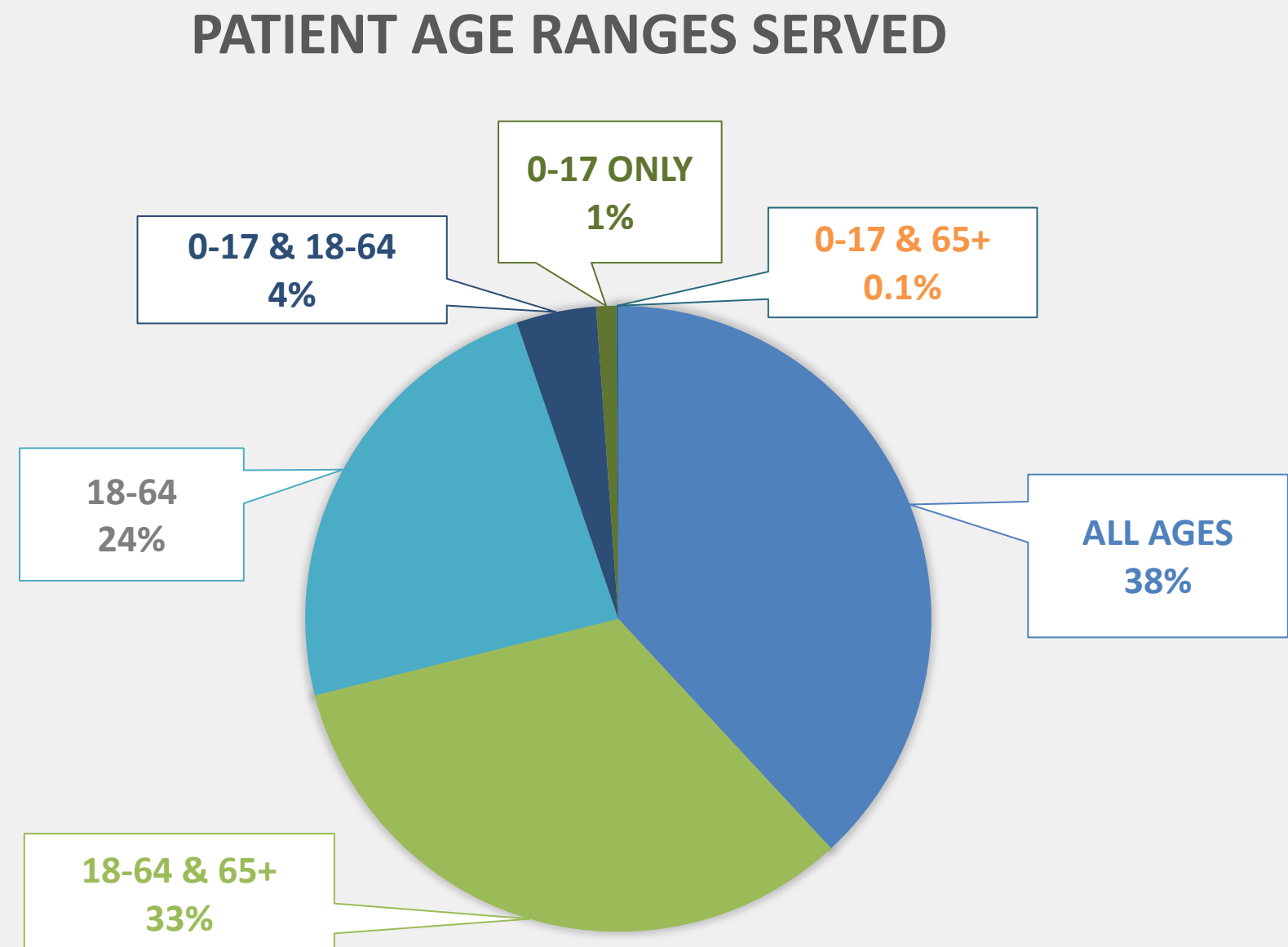
PATIENT DEMOGRAPHICS

Patient Gender Identity:

- 56% of patients identify as female, 40% as male, and the remaining 4% include patients that identify as non-binary, transgender or who chose not to identify.

Patient Age Ranges:

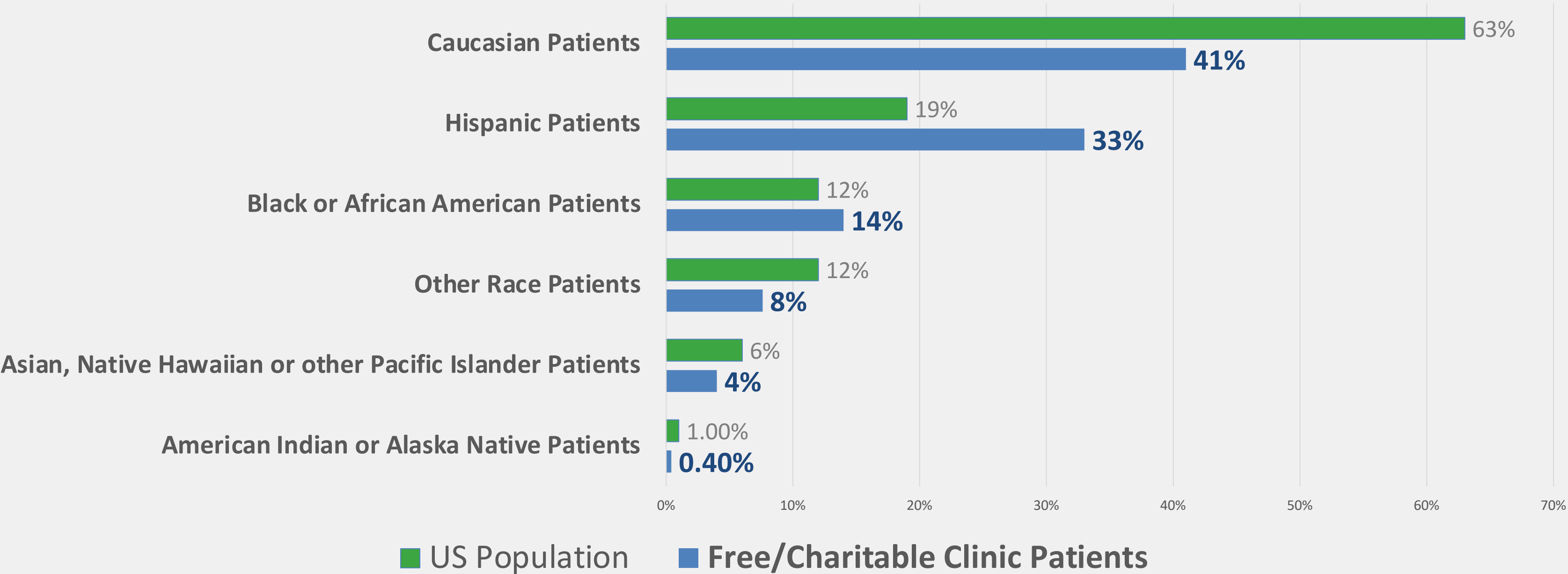
- 96% of clinics serve patients in the age range of 18-64 years old.
- 70% of clinics serve patients in the age range of 65+ years old.
- 43% of clinics serve patients in the age range of 0-17 years old.

Patient Race/Ethnicity

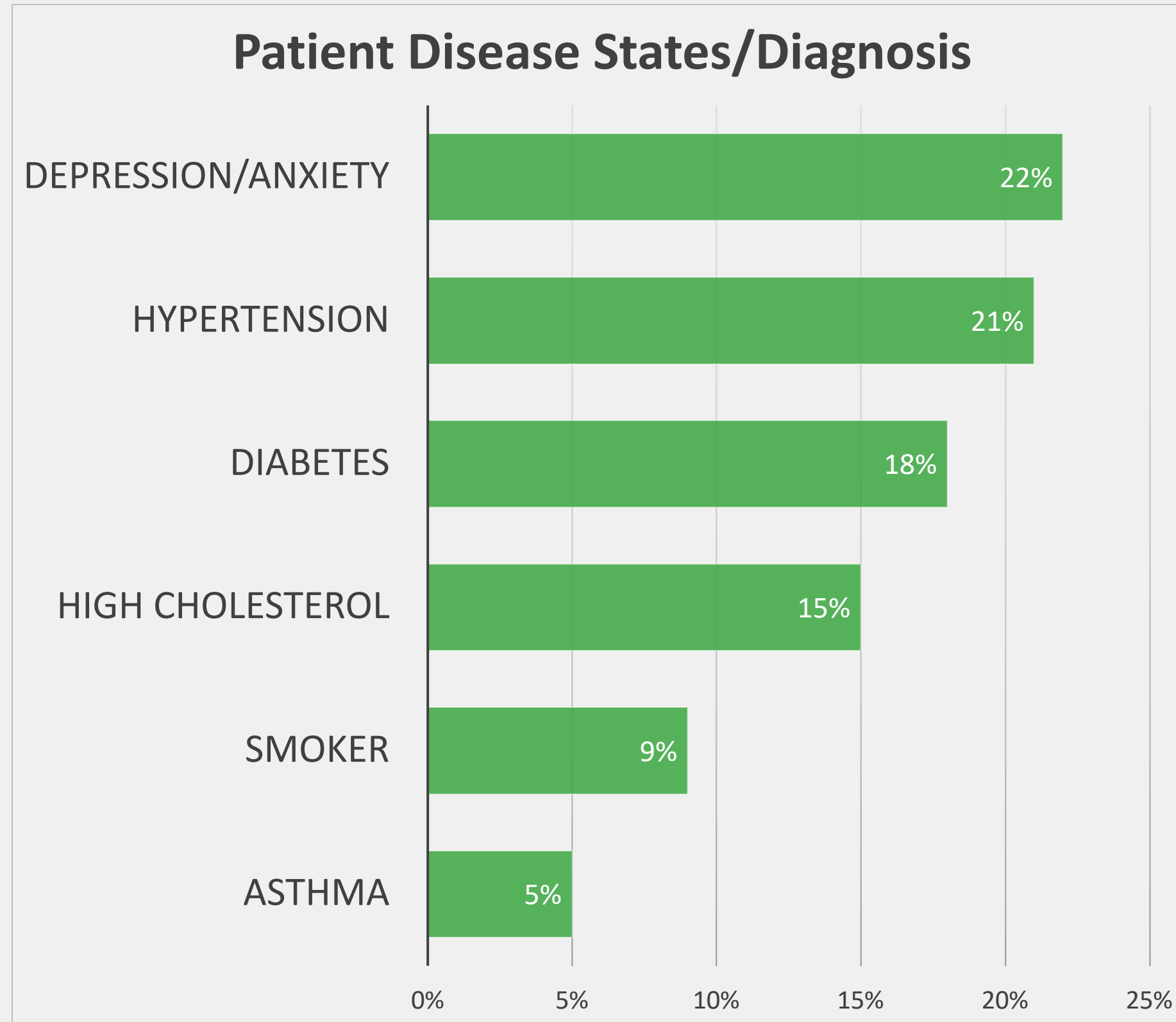
A majority - 59% - of patients were members of racial/ethnic minorities, compared to 37% of the U.S. population.

- With an A1c under 9 – 70%
- With an A1c at or below 7% - 74%



WORKFORCE - VOLUNTEERS

The total workforce – including both volunteers and staff – is 188,000

- 93% of the workforce are volunteers
- Prior to the COVID-19 pandemic, there were 200,000+ volunteers. While the numbers are growing, the need remains.
- A majority of the workforce at free and charitable clinics and pharmacies are women, with 80% of the staff and 58% of the volunteers being women.

There were 12,800 paid staff members at Free & Charitable Clinics and Pharmacies *(12,600 in 2021)*

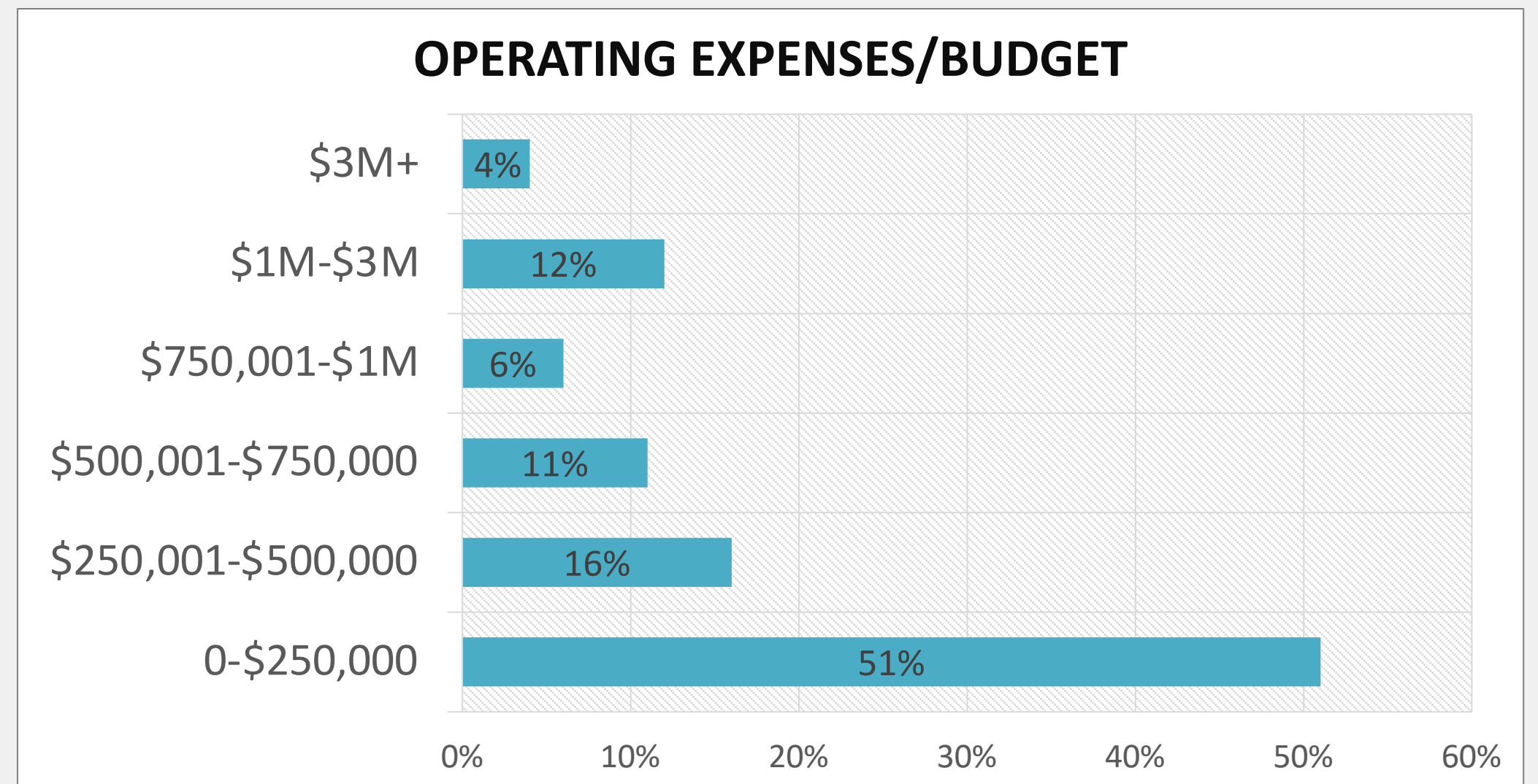

Free and Charitable Clinic/Pharmacies Budget Size:

- 51% of clinics/pharmacies have an operating budget of \$250,000 or less.
- 69% of clinics/pharmacies have an operating budget of \$500,000 or less.
- 15% of clinics/pharmacies have an operating budget of over \$1 Million.

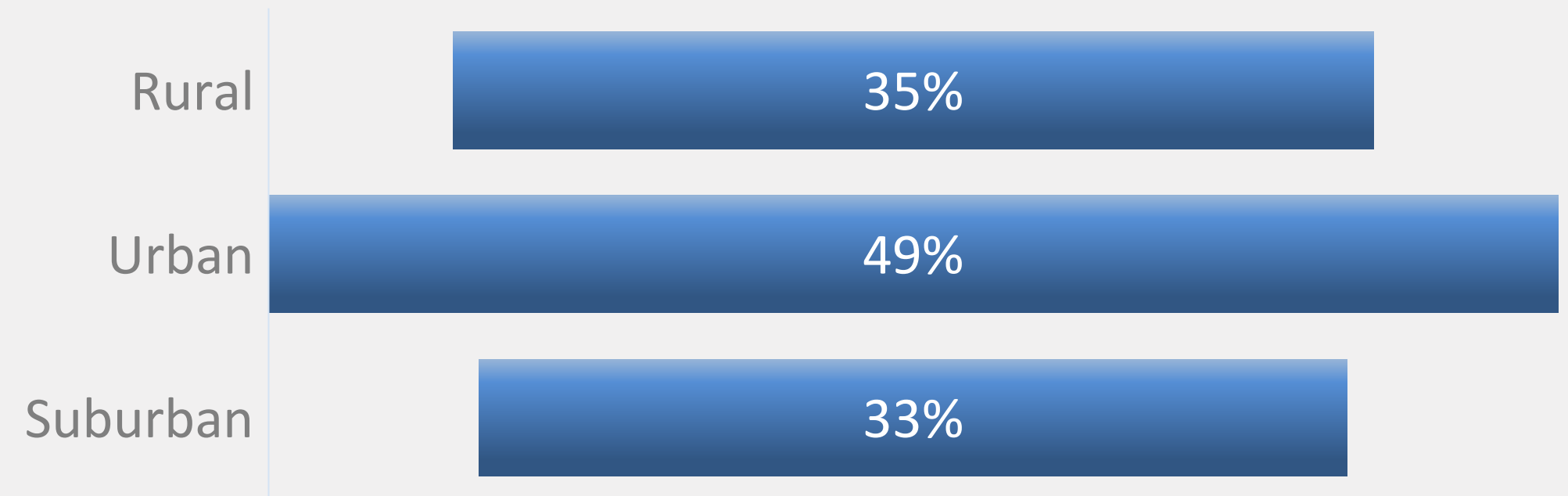

Only 14% of organizations do NOT use an Electronic Health Record/Electronic Medical Record System.

- DataNet Solutions – 3%
- MD Rhythm – 2%
- Dentrix/eaglesoft – 2%



ORGANIZATIONS

Certifications:

- 5% hold a NCQA Patient Centered Medical Home (PCMH) Recognition
- 22% are Federal Tort Claims Act (FTCA) sponsoring clinics
- 4% have been recognized as a Million Hearts Hypertension Control Champion (with 27% interested in learning more)

PAP Form Assistance:

- 69% of organizations help process PAP (patient assistance program) forms for their patients on-site

Pharmacy:

- 46% of organizations have an on-site pharmacy/dispensary
- *63% of clinics with pharmacies have pharmacy management software; 37% of clinics with pharmacies do not have software.*
- For organizations that do not have a pharmacy or dispensary on-site, patients fill their prescriptions at:
 - Walmart – 76%
 - Walgreens – 61%
 - CVS – 57%
 - Kroger – 27%
 - Target – 27%
 - Costco – 27%
 - Publix – 19%
 - Rx Outreach – 12%

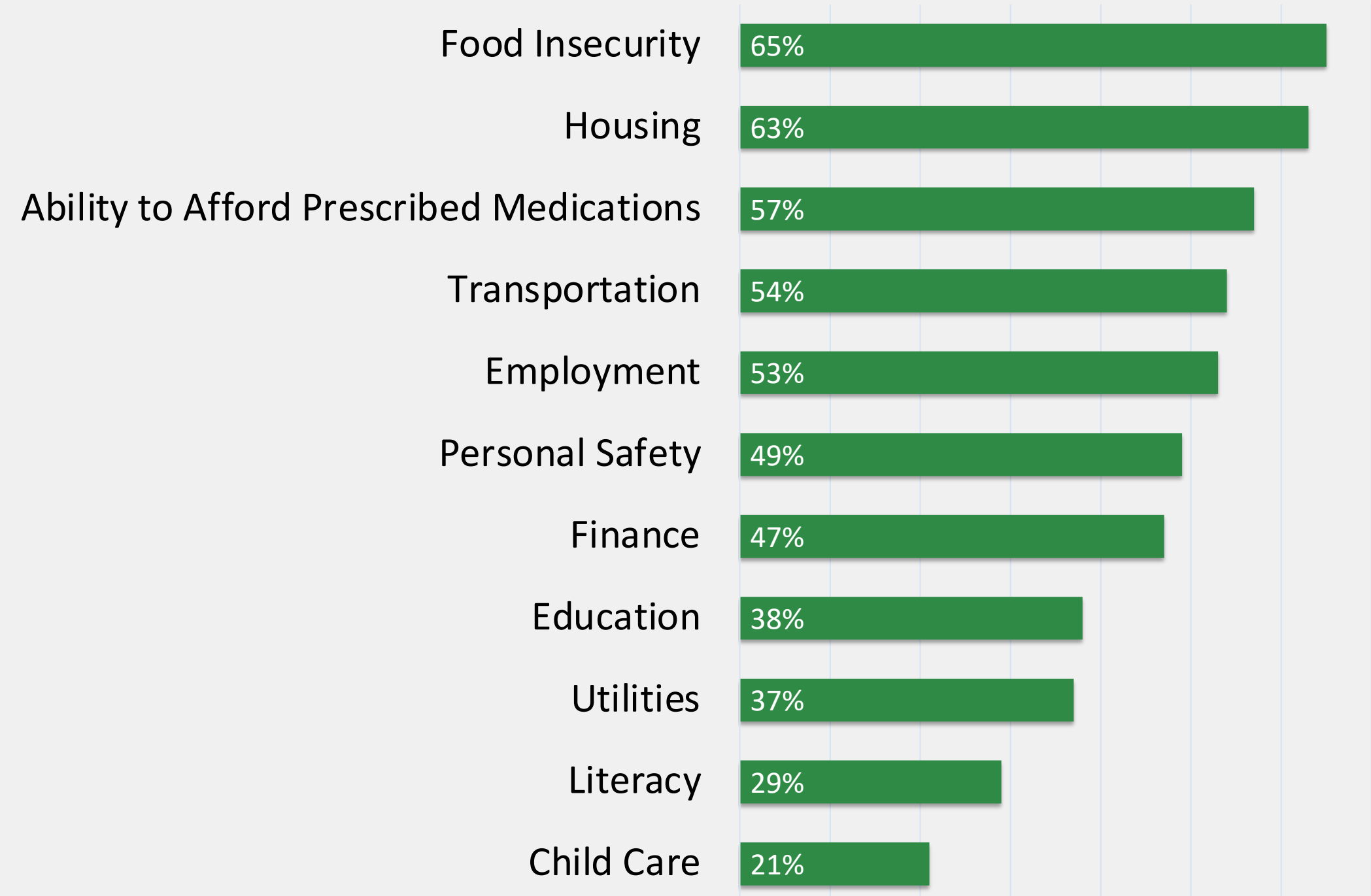


ADDRESSING SDOH

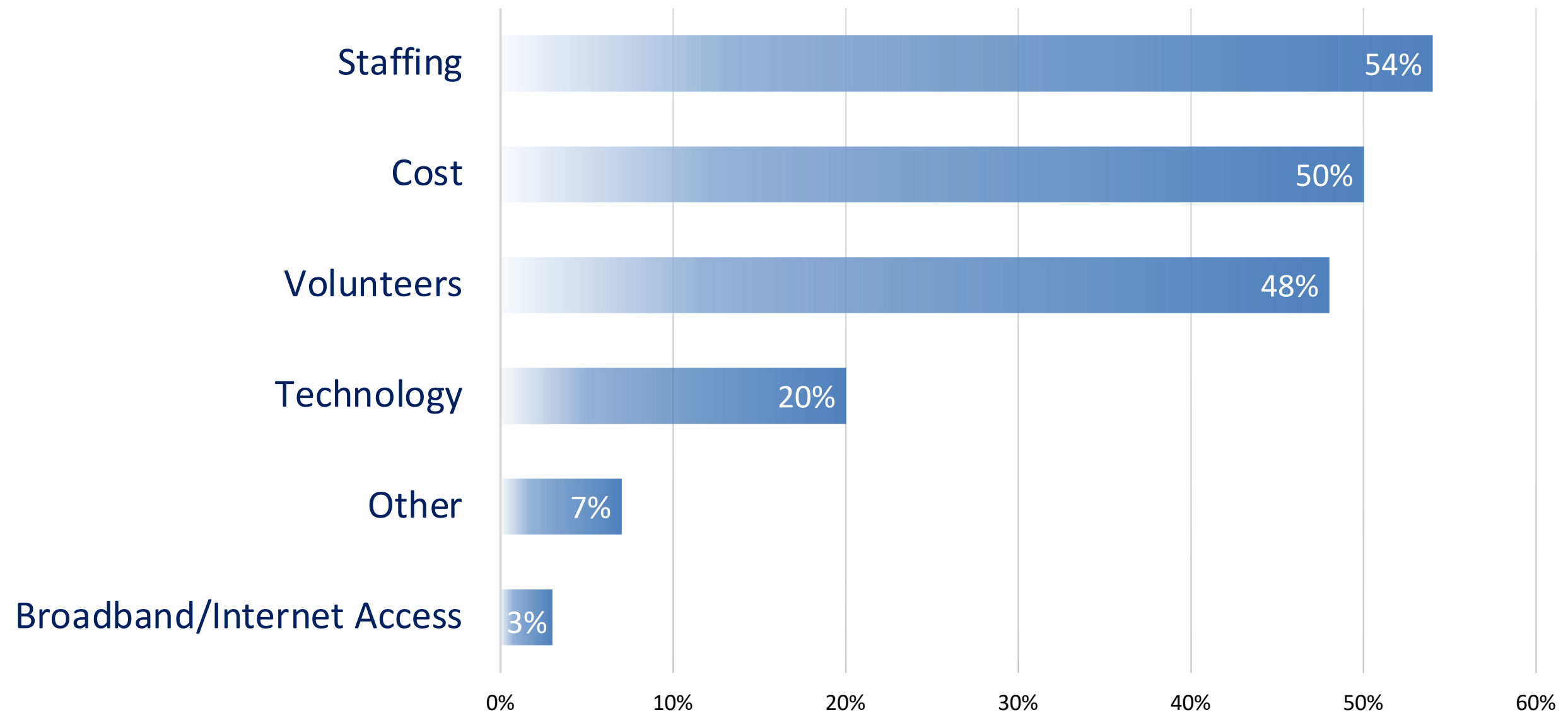

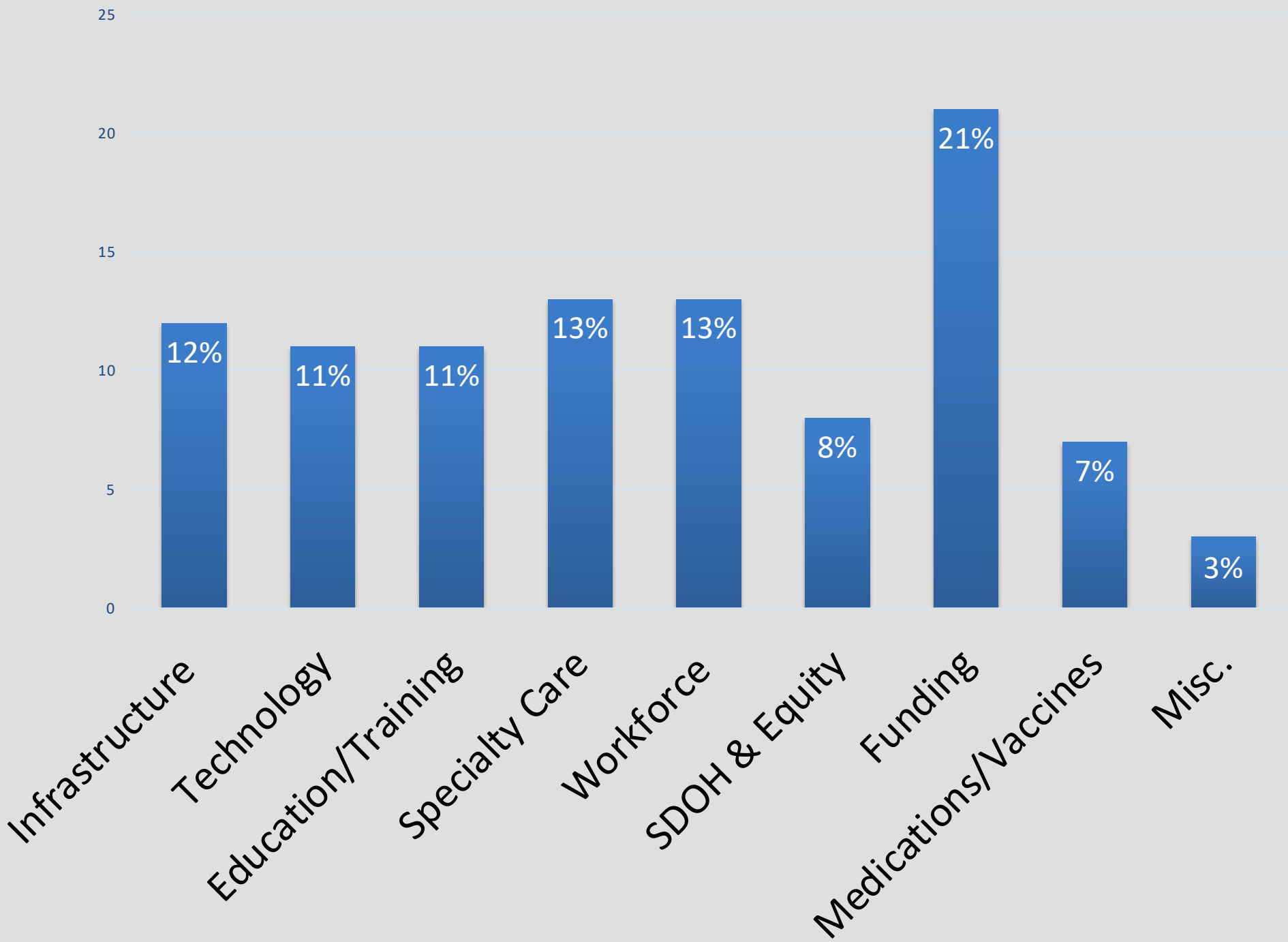
